| <b>4. Entry Restrictions</b>                 | a. Entrants must be:<br>i. at least 18 years of age;<br>ii. residents of NSW.<br>b. Entrants must not be the employees (or their immediate family members) of:<br>i. The Promoter and its related bodies corporate; or<br>ii. The Prize Provider and its related bodies corporate.   |

Continue to listen until later in that specific program when the "Sounds of the Show" sound effect will be played again.<br>iv. When the sound is aired again, within a cue-to-call, phone 2GB on the nominated contest phone number.  |

Participants consent to their personal information (as that term is defined in the Privacy Act 1988) being used for direct marketing by the Promoter and Prize Provider, distribution by the Promoter and uses approved in the Privacy Policy.</p> <p>c. Throughout the Promotional Period the Promoter may contact Entrants to interact with the station on air, online and via social media in relation to the Promotion.</p> <p>d.
